The school offers merit-based admissions, cultivates strong family partnerships, and ensures its economic diversity by meeting all demonstrated need for tuition support.

Harlem Academy is an accredited independent school that introduces high-potential children from low-income communities to an advanced academic environment. Our goal is to go beyond simply overcoming the disparities facing low-income children; we seek to launch students' academic careers by providing opportunities for personal growth, unleashing their creativity, and challenging students at every turn.

Founded in 2004, Harlem Academy has added a grade every year and now serves 111 students in first through eighth grade. At the foundation of Harlem Academy's model is a dedication to rigorous academics, character development, and family partnership.

The school is open from 7:30 a.m. to 6 p.m., providing ample time for a challenging program, an advisory period, after-school tutoring and enrichment, and athletics.

In 2012, first-year students at Harlem Academy saw an average 12 percentile-point increase on nationally standardized tests. One-quarter of our students scored in the top 10% of the nation in English and a third scored in the top 5% nationwide in mathematics. Ninety-four percent of students scored above the national average.

In addition, in 2012, Harlem Academy had its inaugural graduating class. Every graduating student earned admission to a secondary school where they will continue to grow and build upon their success at Harlem Academy. Students from the Class of 2012

accepted offers to attend top day schools, such as Grace Church, Riverdale, and Trevor; boarding schools, including Church Farm (PA), Peddie (NJ), Purnell (NJ), and Stony Brook (NY); and selective Catholic and public schools, with students slated to attend Aquinas, Cardinal Hayes, St. Jean Baptiste, The Academy for Software Engineering, The Facing History School, and Humanities Prep. Harlem Academy's inaugural graduating class accepted more than \$300,000 in annual secondary school scholarships.

In 2012, Harlem Academy provided over \$2.3 million in tuition support to low-income students. Harlem Academy admission decisions are need-blind, based solely on a student's potential for growth in our advanced academic environment. The school then meets each family's full financial need to ensure that every admitted student can attend. The average Harlem Academy family is able to cover only about 10% of the cost of their child's education, with the rest coming from charitable giving by individuals, foundations, and corporations.
