The school offers merit-based admissions, cultivates strong family partnerships, and ensures its economic diversity by meeting all demonstrated need for tuition support.

Harlem Academy is an independent school (grades 1-8) dedicated to expanding access to top secondary schools and tier-1 universities for bright, motivated students whose potential might otherwise go unrealized.

Our students excelled academically: During their first year at Harlem Academy, the average student sees a 13 percentile point increase on nationally standardized tests.

On 2013 testing (ERB CTP4) more than one-third of students achieved at or above the 90th percentile in English, and almost one-half achieved at or above that mark in math. Ninety-six percent of student scored above the national average.

Graduates admitted to top schools: Every graduating student in the first two classes earned admission to a secondary school where they will grow and build upon their success, including Chapin, Peddie, and Hotchkiss. Harlem Academy graduates earned a collective \$570,000 in annual scholarships.

Harlem Academy provided \$2.6 million in full-need scholarships to low-income students: This vital support ensured every admitted student could attend regardless of financial circumstances.
